

THE REGIONAL AT CAPITAN

CAPITAN, NEW MEXICO
September 22, 23, 24, 2017

LOCATION: The range is located 3 miles east of Capitan on the north side of hiway 380.

RULES: Current NRA High Power Rules will apply.

COMPETITION OPEN TO: Any individual NRA member, any junior or adult non-NRA member and any foreign competitor.

REGISTRATION FEES: All competitors must pay with NRA Award Points, check or cash. Make checks payable to: Capitan Hi Power Shooting Club, Inc.

JUNIOR FEES	one half of above amounts
LATE ENTRIES	May be accepted up to limit of range capacity.

INDIVIDUAL ENTRIES: Entries in individual events will be made by using the enclosed entry form, accompanied by a check or money order for the full amount of the entry desired. Entry form must be filled out COMPLETELY AND SIGNED. Make checks payable to the Capitan Hi Power Shooting Club. Mail entries to:

TEAM ENTRIES: Team entries are subject to rules 2.10 to 2.20

STAT OFFICE OPENS AT 0700.

SQUADDING: All matches will be squadded. Squadding for individual matches will be issued from the Stat Office to competitors who check in at the Stat Office. No squadding will be issued on the firing line. A competitor who fails to obtain his squadding, or who fails to be at the proper firing point when his relay is called may lose his privilege to compete in that event.

TEAM SQUADDING: Announced on the range. One team member will go to the pits and pull a target assigned to him by the pit officer.

COMPETITORS WILL PULL TARGETS AND SCORE

SCORING: Rule 14.18a

INDENTIFICATION: NRA membership card and classification cards must be shown before any squadding will be issued.

CLASSIFICATION: The NRA classification will be used in all matches. Unclassified competitors will compete in the Master Class. Rule 19.6 (assigned classification) or 19.2 (temporary classification).

RIFLES AND SIGHTS: Service Rifle (3.1, 3.1.1, 3.1.2, 3.1.3), Match Rifle (3.3, 3.3.1, 3.3.3) and Any Sight Match Rifle (3.3.4). For the 600 yard matches, Service rifle (3.1, 3.1.1, 3.1.2, 3.1.3), Match rifle (3.3, 3.3.1, 3.3.3) and Any rifle (3.2), iron sights and any sights. F class rules for the 600 yard matches on Friday.

TARGETS: 200 yds. SR; 300 yds., SR-3; 600 yds., MR-1

CATAGORIES AND CLASSES FOR AWARDS: There will be class awards.

AWARD DISPOSITION: The awards will be cash and trophy. There must be 5 or more entries in a class for 1 award, 10 or more for 2 awards etc. Team Match: one award for every 4 teams.

AGGREGATE AWARD SCHEDULE: REGIONAL CHAMPIONSHIP AWARDS, MATCH 5:

NATIONAL CHAMPIONSHIP CREDIT AWARD

The highest shooter in each class (**providing there are a minimum of 5 shooters in that classification in the Grand Aggregate**) will receive \$40.00 credit toward entry fees to Camp Perry for this discipline. The credit is valid for **13 months** and is **NOT TRANSFERABLE**. An individual may win more than one credit within a "Camp Perry year", but cannot exceed entry fees.

A total of only 5 credits will be given. A credit will be given to the highest High Master, Master, Expert, Sharpshooter and Marksman (min. 5 competitors each) without regard to category (**no combining of classes**). The overall winner of the Regional will win a credit regardless of the number of competitors in his/her class if not in a class with 5 shooter in it.

Match 6: 2 sighting shots and 20 shots for record in 22 minutes, prone at 600 yards, ANY SIGHT, F class

Match 7: 2 sighting shots and 20 shots for record in 22 minutes, prone at 600 yards, IRON SIGHT, F class

Match 8: Aggregate of match 6 and 7

HIGH POWER RIFLE 4 MAN TEAM

Friday, September 22, 2017

1:00 Start

2 sighters and 10 shots standing, slow fire, 200 yds. block time: 27 minutes per pair.

2 sighters and 10 shots prone rapid fire, 300 yds. 70 seconds

2 sighters and 10 shots prone, slow fire, 600 yds. block time: 27 minutes per pair.

HIGH POWER RIFLE REGIONAL CHAMPIONSHIP

Saturday, September 23, 2017

0800 Start

MATCH 1: 2 Sighting shots and 20 shots for record, standing, slow fire, 200 yds. Rule 5.12

MATCH 2: 2 Sighting shots and 20 shots for record, sitting or kneeling rapid fire, 200 yds. Rule 5.8 or 5.10. CONTRARY TO RULE 11.76 (b), EACH RELAY WILL FIRE MATCH 2 IMMEDIATELY FOLLOWING MATCH 1. PREPARATION TIME FOR SITTING RAPID WILL BEGIN 3 MINUTES AFTER COMPLETION OF THAT RELAY'S STANDING.

MATCH 3: 2 Sighting shots and 20 shots for record prone rapid fire, 300 yds. Rule 5.6

MATCH 4: 2 Sighting shots and 20 shots for record, prone, slow fire, 600 yds. Rule 5.6.

MATCH 5: Regional Championship: Aggregate of scores fired in matches 1, 2, 3 & 4.

SERVICE RIFLE & SERVICE PISTOL EIC MATCHES & CONCURRENT FUN MATCH

Sunday, September 24, 2017

0800 Start

It is not necessary to enter the NRA matches to fire in this event. The Leg Match and Fun Match will be run concurrently. The fun match is for match rifle shooters that wish to shoot the leg match with no sighters.

1. OPEN TO: Any citizen of the United States, 16 years of age or older.
2. RULES: CMP Competition Rules, 10th Edition
3. ENTRY LIMITS: Range capacity
4. ENTRIES: To compete the OFFICIAL NBPRP Entry and Score Card must be obtained from the Range Officer Sunday morning.
5. ENTRY FEES: \$20.00 paid by the individual (including military personnel)
6. AUTHORIZED ARMS: Service Rifle as prescribed for use in the Leg Match at the National Matches
Fun Match: Service Rifle and NRA Match Rifle (3.3, 3.3.1) or Any Sight Match Rifle (3.3.4)
7. AMMUNITION: Any safe ammunition. No flat base bullets may be used at 600 yds.
8. COURSE OF FIRE: NATIONAL MATCH COURSE: 50 shots, no sighters

STAGE 1 AND 2 WILL BE FIRED BEFORE A RELAY LEAVES THE LINE

Stage 1: Slow fire, 10 shots standing, 200 yds. in 10 min. The sling must be attached to the rifle in the parade position, and it cannot be used for support.

Stage 2: Rapid fire, 10 shots, sitting or kneeling from standing, in 60 seconds.

Stage 3: Rapid fire, 10 shots, prone from standing, in 70 seconds

Stage 4: Slow fire, 20 shots, prone in 20 minutes

9. AWARDS: Credit toward Distinguished designation and appropriate Excellence in Competition badges as provided in AR 622-10 and AR 672-5-1. Awards for the Fun Match will be given without regard to NRA classification or rifle type.

SPECIAL NOTE: You must send us a notarized copy of the CMP's "Eligibility Affidavit and Liability Agreement" in order to compete in the leg match. We must have a copy (it can be photo copied from the original) every time you shoot a CMP match. Although CMP requires just one affidavit per lifetime, there is no practical means for us to know, at the match site, that the shooter has submitted an affidavit to us or to some other organization before today's match.

Please note, if we have one already on file, there is no need to send another.

EXCELLENCE IN COMPITION PISTOL MATCH

The CMP Service Pistol Match sponsored by: Capitan Hi Power Shooting Club, Inc.

Eligibility: Open to all eligible participants. You need not be a member of the NRA or a CMP affiliated club to participate.

Time & Date: September 23, 24, 2017. There will be a relay or two on Saturday after the regional, depending on the number of shooters and time before dark. We will run those relays after the conclusion of the regional match on the 23th. Then any final shooters on the 24th after the conclusion of the EIC Rifle match.

Squadding: Squadding will be on a first-come first serve basis, and shooters may choose the day/relay they wish to shoot within this parameter.

Fee: \$20.00

Course of Fire: 30 shot National Match Course of Fire (see rule 7.3.1 Table 6)

Firearm: "Service Pistol" as defined in the Current Edition of the CMP Rule book (see rule 6.3) and Standard Smallbore Pistol, caliber .22 rimfire (see rule 6.4)

Entries: Entries will be limited to 30 shooters. There must be at least six non-distinguished shooters. Non-Distinguished shooters will get priority.

Awards: EIC points towards Distinguished Pistol Shot Badge. All awards and points will be issued by the CMP.

Rules: In accordance with the current edition of the CMP Rulebook. All EIC Service Pistol Matches will be governed by CMP Rules.
